She has already submitted an application for a credit card from Greenfield Bank to start the process.

8. DEPARTMENT REPORTS

Town Manager Jim Robinson - Discussed the crash report on the light pole that was damaged by the uninsured driver. He stated that the small claims court form from the Clerk's office can be filed electronically. Bill Niemier stated that the driver is responsible for paying for the damages.

Street Commissioner Stephen Pool - Discussed Community Crossings and said he tossed the low bid due to multiple errors. Dave O'Mara will be awarded the contract. He spoke about Summerfest, and getting detours set up. He also discussed the Bittner Bridge closure and repair situation, and stated that we will know more after the reports come in. He stated that everything has to go through CSX. Ryan said we have to go through the permitting process with CSX as well, and it could be a lengthy process.

Police Chief Bob Ehle - Next week, the department will go through active shooter training with other area departments. He also requested approval of the purchase of a level 3A Ballistic Shield which will cost from \$2,000 to \$3,000.

Yvonne Jonas - Spoke about budget time and talked through some dates for the budget meetings with Jarod Hall. She explained the process, and she will send out an email to everyone.
