Town of New Palestine Town Council Wednesday, December 16, 2020 7:00 PM - Town Hall

The Town Council of the Town of New Palestine was called to order on Wednesday, December 16, 2020, at 7:00 PM, in the Town Hall, with the following members present:

PRESENT: Council Vice President Clint Bledsoe, Council Member Angela Fahrnow,

Council Member Chris Lytle, Council Member Bill Niemier, Clerk-Treasurer Yvonne Jonas, Infrastructure Stephen Pool, and Police Chief Robert Ehle

ABSENT: Council President Brandee Bastin

1. CALL TO ORDER

1.1. Pledge of Allegiance

2. MINUTES

- 2.1. Approval of Minutes 12-2-2020 Angela Fahrnow motioned to approve, Bill Niemier seconded and motion carried with 4 ayes.
- 2.2. Approval of Minutes 12-11-2020 Bill Niemier motioned to approve, Chris Lytle seconded and motion carried with 4 ayes.

3. NEW AGENDA ITEMS

3.1. West End Extension-Dr. Trevor Lloyd Jones

Trevor Lloyd Jones did not attend the meeting.

3.2. Sewer Territory with Triad

Kent Schuch spoke about throwing out the single bid for pump improvements and would like permission to move ahead and re-bid. (Gem Road Force Main) Waiting on a permit from IDEM.

Bill Niemier made a motion to re-bid, Angela Fahrnow seconded and motion carried with 4 ayes.

Mr. Schuch spoke about trying to get an appointment with the Hancock County Water Sewage District in regard to the New Pal Sewer district area. Copies sent to Cumberland, Doe Creek Utilities, and Nine Star.

Clint suggested that this adds a lot of protection. Jim Robinson suggested a new

master plan for sewer.

Kent Schuch passed out his 2021 Professional Services Agreement Contract for the council to review.

4. OLD BUSINESS

4.1. Chamber of Commerce Contract

Contact was approved from 1-1-2021 to 12-31-2021. Bill Niemier motioned to approve the contract, Chris Lytle seconded and the motion carried with 3 ayes and one nay (Clint Bledsoe).

5. NEW BUSINESS

5.1. Due to impact of Covid-19/Cares Act Funding -Scott Wells presented that town had received notice of additional Cares Act funding (\$8034.00 maximum), with an additional 10% on the table that can be used for employee virtual meeting training and some communications. Virtual Workforce Training purchase will be \$475 per user to include: headphones/speakers/camera/microphone.

Council Member Angela Fahrnow moved, seconded by Council Member Bill Niemier, 4-0
